WAIVER AND RELEASE OF LIABILITY & SAFETY RULES

In consideration of **Realms of Ruin Inc** furnishing services and / or equipment to enable me to participate in Paintball and / or Airsoft games, I agree as follows:

I fully understand and acknowledge that; (a) risks and dangers exist in my use of Paintball and / or Airsoft equipment and my participation in Paintball and Airsoft activities; (b) my participation in such activities and / or use of such equipment may result in my injury or illness including but not limited to bodily injury, disease strains, fractures, partial and / or total paralysis, eye injury, blindness, heat stroke, heart attack, death or other ailments that could cause serious disability; (c) these risks and dangers may be caused by the negligence of the owners, employees, officers or agents of **Realms of Ruin Inc** the negligence of the participants, the negligence of others, accidents, breaches of contract, the forces of nature or other causes. These risks and dangers may arise from foreseeable or unforeseeable causes; and (d) by my participation in these activities and / or damages, whether caused I whole or in part by the negligence or other conduct of the owners, agents, officers, employees, of **Realms of Ruin Inc**, or by any other person.

I, on behalf of myself, my personal representatives and my heirs, hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify **Realms of Ruin Inc** and it's owners, agents, officers and employees from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of my use of Paintball and / or Airsoft Equipment or my participation in Paintball and / or Airsoft activities, I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for the negligent acts or other conduct by the owners, agents, officers or employees of **Realms of Ruin Inc**. This waiver is valid until 04/01/11.

1. All players must wear approved FULL FACE MASK / GOGGLE SYSTEMS at all times past the neutral areas, "Goggles On" areas, or when in the target range testing your marker.
2. No shooting into or out of the registration area, neutral zones, or parking areas. All markers must have BARREL BLOCKING DEVICES in while in these areas. BARREL BLOCKING DEVICES are not squeezegees or rags or towels. Markers may only be discharged on the playing field or in the target range.
3. Barrel blocking devices will be removed on the field of play ONLY when permission is given by a JUDGE.
4. Do not shoot the wildlife.
5. Do not shoot at airplanes, parachutists, automobiles, etc.
6. No climbing of trees or on top of structures.
7. No physical contact whatsoever.
8. No potentially dangerous gear. Players may not bring any form of tools onto the playing field. No types of firearms, pyrotechnics, or explosives are allowed. The manager must approve all personal equipment.
9. Avoid field hazards.
10. Construct no booby traps.
11. NO ALCOHOL or illegal DRUGS allowed on the premises. We reserve the right to refuse service to anyone that appears to be under the influence of alcohol or illegal drugs.
12. Smoking is allowed only in the registration area.
13. No verbal abuse.
14. Do not attempt to remove any components from rental markers or other rental equipment.
15. No blind shooting. Players may only shoot at what they can see.
16. All JUDGES' decisions are FINAL! No players will be allowed to argue with any judge.
17. Spectators must wear full face goggles / mask with ear protection unless behind safety netting that has passed a safety certification process. The spectators must be 2 feet back from netting and not be leaning against it.
18. Trigger guards are mandatory. It must encompass the whole trigger. Regulators are NOT trigger guards.
19. Semi auto mode ONLY on the field of play. No turbo, burst reactive trigger, full auto, or rip modes.

I have read the above waiver and release and by signing it agree it is my intention to exempt and relieve **REALMS OF RUIN INC** from liability for personal injury, property damage or wrongful death caused by negligence or any other cause, and that the player is at least 10 years of age and in good health. I acknowledge that I have read every rule and fully understand them. I agree to follow all rules mentioned above while at Realms Of Ruin Inc and certify so with my signature below.
